**New Mexico COVID-19 update: 1,127 new cases,  
totaling 500,516**

*Twenty-nine additional COVID-19 deaths, 7-Day positivity  
rate 17.9%*

SANTA FE – New Mexico state health officials on Friday announced 1,127 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

\*COVID related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

As of today, there are 498 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 376,960 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;

- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
