Traffic Report for week of March 20 to 27, 2022

In all construction zones, motorists are asked to reduce speed, obey posted signs, and use extreme caution, as well as continue to be cautious of heavy equipment and construction personnel in the area. PLEASE NOTE: Conditions are subject to change without notice. Double fines for speeding in work zones may be in effect.

Interstates:

I-10, Mile Marker 116 to 139, Las Cruces

The New Mexico Department of Transportation (NMDOT) District One will be continuing Fog Sealing I-10 from Las Cruces towards Deming. Drivers can expect lane closures westbound beginning at milepost 139 (Motel Blvd/NM 292) to 116 (NM 549). One lane of traffic will remain open, off and on ramps will be close temporarily. Speed limits will be reduced.

I-25, Mile Marker 34 to 39, Rincon Willows

Mountain States Constructors, Inc. (Contractor) is continuing with the roadway reconstruction project on I-25 north of Las Cruces. All traffic has been shifted into the northbound bound lanes utilizing crossover detour and barrier wall separation so southbound construction can begin. The southbound Rincon on and off ramps will be closed, follow detour signage. This closure is expected until summer 2022. Hours of operation will be from 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

I-25, Mile Marker 14 to 24, North of Las Cruces CN11016

Mesa Verde Enterprises, Inc. (Contractor) will be continuing a roadway reconstruction project on Interstate 25 from milepost 14 to 24, just north of Las Cruces. Drivers can expect various daytime lane closures on both the northbound and southbound lanes as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Saturday.

I-25, Mile Marker 117 & 121, North of Truth or Consequences

Hasse Contracting Co. will be making repairs to the bridges on I-25 at milepost 117 and milepost 121. Traffic can expect lane closures on I-25 on the southbound lanes until the bridge deck repairs are complete, one lane will remain open. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m., traffic control will remain in place 24/7. Use caution for workers and equipment in the area. Repairs are expected to be completed by summer 2022.

I-10, Mile Marker 21 to 23, Lordsburg

AUI, Inc. (Contractor) is currently building the bridge deck on the westbound lanes. All interstate traffic is rerouted to the eastbound I-10 lanes as the contractor completes construction of the westbound I-10 bridge. Detour signs will be in place to direct traffic towards alternate routes. Daily hours of operation are 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

I-10, Mile Marker 24.9 to 35, Lordsburg

Mountain States Construction, Inc. (Contractor) has finalized all paving on I-10 from milepost 24.9 (Lordsburg East) to milepost 35. A sub-contractor is completing the upgrades to the barrier wall. If needed drivers can expect lane closures on both the eastbound and westbound lanes as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday.

I-10, Mile Marker 15 to 20, Lordsburg Willoub 20

Mountain States Construction, Inc. (Contractor) will be continuing a pavement rehabilitation and reconstruction project on I-10 from milepost 20 (Lordsburg West) to milepost 15 (Gary). Drivers can expect various daytime lane closures on both the eastbound and westbound lanes as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday.

US Roadways:

US 70, Mile Marker 144 to 162, Las Cruces

A-Mountain Construction (Contractor) will begin a safety improvement project along US 70 from Picacho Ave at the Rio Grande River to the town of Organ. This project includes the replacement of sidewalks, curb & gutter, driveway pads and attenuators abutments at spot locations. Starting Monday, Mar. 21, 2022, crews will have various lanes closures in place. Reduce your speed and use caution for employees and equipment in the construction zone. Construction hours will be from 7 a.m. until 5 p.m., Monday through Friday. This project is expected to take approximately 3 weeks to complete.

State Roadways:

NM 140, Mile Marker o to 1, Rincon Chilous

Hasse Contracting Co. (Contractor) will be continuing the Bridge Preservation projects in Southwest, NM. NM 140 is closed from milepost 0 to 1, a detour is in place. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. Use caution for workers and equipment in the area. Bridge is expected to be closed until March 30, 2022.

NM 427 (Florida St. & S. Lead), Deming

CableCom, LLC. (Contractor) will have shoulder work in place on NM 427 "Florida St." and S. Lead St. for Coaxial Cable repairs. Contractor will be in the area on Thursday, Mar. 24, to Friday, Mar. 25, 2022, from 9 a.m. to 4 p.m. Use caution for employees and equipment in the area, speed limit will be reduced.

NM 9 Mile Marker 11 to 12, Animas

The New Mexico Department of Transportation (NMDOT) will be performing roadway repairs on NM 9 from milepost 11 to 12. A flagging operation will be in place. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area. This closure will be in place daily from 8 a.m. to 5 p.m., Monday through Thursday.

NM 273 Mile Marker 2, Sunland Park

The New Mexico Department of Transportation (NMDOT) has a lane closure in place for the City of Sunland Park due to required roadway repairs on NM 273 "McNutt Road" at milepost 2. The driving right lane is expected to be closed through May 2022. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

NM 404 and I-10 Bridge Replacement, Anthony E100202

AUI, Inc. (Contractor) is continuing with roadwork and replacement of the NM 404 Bridge over I-10 at milepost 162, Anthony exit. Traffic is currently using new bridge as Contractor constructs the other half of the bridge. Please follow detour signage in the area, expect delays. Traffic is open to one lane in each direction. Daily contractor hours of operation are from 7 a.m. to 5 p.m., Monday through Saturday. Traffic control will remain in place 24/7.

City of Las Cruces Projects:

Peachtree Hills Road

Peachtree Hills Road between Sonoma Ranch Boulevard and Metro Park Street has been opened to two-way traffic. Temporary traffic control and lane merges in the roadway alignment remain in place. Motorist are urged to obey all placed warning signs.

Magdalena Drive

Magdalena Drive is scheduled to undergo roadway improvements by Caliper Construction Company, Inc. as part of the Magdalena Pond Repair Project. The following lane closure will be in place. Traffic on Magdalena Dr. has been shifted to the east, with two lanes of traffic opened southbound and northbound. Crews are working on the shoulder of Magdalena Dr. between the San Miguel Ct. and Borroughs. This lane closure is estimated to last approximately 9 weeks depending on weather conditions. Work will take place between 7 a.m. and 3 p.m., two-way traffic will be maintained.

South Main Street, NM 478
The City of Las Cruces Utilities Department will have shoulder work in place from Los Nogales Dr to Wonder Lane along NM 478, S. Main Street. Starting on Monday, Mar. 21, to Friday, Mar. 25, 2022, from 7:30 a.m. to 2:30 p.m. Use caution for employees and equipment in the area, speed limit will be reduced.
