*I-25 from Lohman to Doña Ana Interchanges and NM 320 (Thorpe Road)*

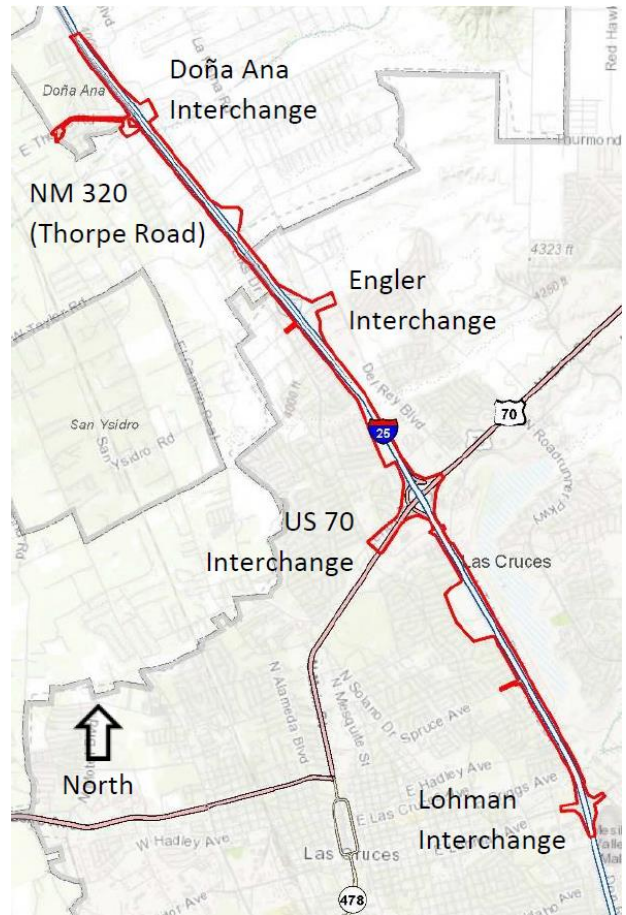
The New Mexico Department of Transportation (NMDOT), in cooperation with the Federal Highway Administration (FHWA), is hosting an In-Person Public Meeting for the I-25 Safety & Capacity Study. This is NMDOT Control Number LC00380.

The **purpose of the Public Meeting** is to go over the alternatives considered and study team recommendations, and to receive your input. A presentation will be given followed by a question-and-answer session.

The I-25 Safety & Capacity Study is for I-25 from the Lohman Interchange to the Doña Ana Interchange and NM 320 (Thorpe Road) from Barela Drive to I-25. This project is to improve safety, accommodate regional growth, and address deficiencies (e.g., pavement, drainage, Americans with Disabilities Act facilities, roadway geometry, access control, and multi-modal connectivity). ### NEXT STEPS

After reviewing public and stakeholder input, the study team will finalize the recommendations and submit the report for FHWA concurrence in Summer 2024. NMDOT will then develop plans for improvements in phases starting with the section on I-25 between the Lohman Interchange and the US 70 Interchange (Phase 1). Construction of Phase 1 is anticipated in late 2028.
